CONFERENCE OVERVIEW



The Indian IT security and Cyber security landscape is projected to be a \$3.54 Billion Market by 2027. Surging demands for security protocols and processes due to increasing adoption of digitization, cloud migration and data theft patterns are driving the growth of the Indian Cyber Security Market in the next 4 years.
